MRC UPDATES

MRC Builds New Partnership

Contra Costa MRC relies are partnerships to help with normal state operations. These partnerships provide additional opportunities in community outreach and education, CPR/AED training, flu vaccine clinics, and disaster training and exercises. Over the past few months the MRC has successfully partnered with Loma Vista/ Mnt Diablo Adult School. This school is located in Concord



and focuses on providing technical training and education for adults looking for career advancement. They offer programs in Medical Assistance, Surgical tech, Dental Assistance, Emergency Medical Technician and Certified Nursing Assistance. These programs offer the perfect opportunity for recruitment and student opportunities with the MRC. A class of 20 Medical Assistants recently participated in a medical surge tent drill with the MRC and Kaiser-Richmond, then played as volunteer victims for a drill at Kaiser-Walnut Creek as part of Super Bowl preparedness. The school invited the MRC to provide flu vaccines as part of a heath fair offered to the community.

Mary, one of our volunteer nurses had this to say, "We were able to vaccinate 20 visitors and take time to see what else the fair was showing... They were very glad to have us there and it is an event we would like to return to again next year".

Later this month, the MRC Coordinator will provide the students with a presentation about the MRC and Valley Fire Response, in hopes of recruiting some new team members.

We are optimistic that this new partnership with continue to grow providing several more opportunities for both the MRC and the students at the school.

The CCCMRC is making on impact on Public Health

Aside from the H1N1 response, this is the first year the MRC has been providing seasonal influenza vaccines to the community in an effort to assist the public health department vaccinate much of the county. There have been some challenges to the clinics we have hosted, but all have provided an excellent training opportunity and opportunities to improve and plan for next year. The flu season is hardly over, but the MRC has made a great impact so far. We have held four clinics since October. This

has provided nearly 170 vaccines. The MRC provided 63.5 volunteer hours at these clinics leading to an economic impact of \$2385, by using volunteers.

Competency Corner

What is a Disaster Service Worker?

The state of California has what is know as the Disaster Service Worker (DSW) Volunteer Program. This program was created to provide worker's compensation coverage for volunteers during authorized disaster-related activities and some pre-approved training. In order to receive this benefit or coverage, volunteers must be registered as DSW volunteers, including receiving the oath from an authorized county official. The worker's compensation coverage does not apply to day-to-day emergency response activities typically carried out by fire, EMS or law enforcement. The Contra Costa Medical Reserve Corps participates in the DSW program and is one of the accredited councils to swear in

volunteers and receive coverage for authorize training and carrying out medical services during disasters. Additionally, any Contra Costa County employee is sworn in as a DSW and is expected to be available for disasters. If you are a county employee, and an MRC member, your obligation remains work work first. CCCMRC swears in all MRC volunteers as part of the application process, so they can be ready to deploy quickly if needed. Should you have an injury while performing a duty with the MRC you are to report it to the unit lead or Coordinator immediately. The MRC deployment binder has all the necessary forms and information for submitting a claim. To learn more information you can visit www.caloes.ca.gov. There is also a short video assigned to unit members with MRC-TRAIN accounts. This video is located under-training plans-tier 1. It is recommended you watch this video for more information about the DSW program.

CCCMRC moves to competency based training

In effort to align with National MRC objects, the Contra Costa MRC has launched its 2016 training program. This training program focuses on the MRC Core Competencies. As part of our training program, an annual schedule will be created and align with three tiers. The training tiers are not required per say, but are away to track the level of training each members has. A member who attends most of the meeting, or completes training on MRC-TRAIN will quickly be of tier 3 status. We understand you are all volunteers and value your free time. Do not feel you need to complete all this training to be able to deploy or participate in MRC events. All members with a completed application can deploy. The tiers allow the coordinator to gage the level of training each member has. Additionally, the coordinator can use this information when talking to outside parties about the MRC, and its preparedness level when compared to a spontaneous volunteer as an effort to have more roles for the MRC in disasters. All members are tier 1 status, once they complete the basic requirements of the application and complete their FEMA and PFA training. Over the next month, each members files will be updated to reflect their tier status and you will receive a copy of this. Our goal is to have 50% of the unit trained at tier 3 by 2016. As part of this training plan, you are to have an MRC-TRAIN account, and can utilize this platform as a training tool to supplement different meeting topics, and work through the tiers. There will still be the requirement of two MRC attendances a year.
